20.34 **TERMS OF REFERENCE – TO NOTE THE TERMS OF REFERENCE UNDER WHICH THE UNIVERSITY AND FACULTY RESEARCH ETHICS COMMITTEES OPERATE**

The Committee noted the terms of reference under which both university and faculty Research Ethics Committees operate.

20.35 **MINUTES OF THE PREVIOUS MEETING**

The minutes of the meeting held on 23 February 2021 and summary of decisions made were agreed as an accurate record.

20.36 **MATTERS ARISING FROM THE MINUTES**

36.1 Ethics Training (v min 26.1)

The Committee Secretary recalled that the Committee had agreed at its last meeting that all researchers would be encouraged to complete the online Epigeum research ethics training. Implementation would be phased in initially to give staff sufficient warning to complete the training. From the 2021/22 academic year completion of the training would become mandatory.

The in-house face to face research ethics training provided by Peter Garrod, Mark Goss Sampson and Lucy Fincham would continue as an optional supplement to the online training. Any additional training needs that were particular to the research areas of individual Faculties would fall to the responsibility of the Faculty.

The Committee Secretary reported that he had not had a chance to check with RETI whether all the research proposal applicants being considered at this meeting had undertaken the Epigeum training. However, it would be made clear to them, with the outcome of their applications, that they were expected to do the training. All applicants had completed the University's mandatory data protection and information security training.

Following a query from the FEHHS FREC representative, it was agreed that RETI would be asked to clarify which categories of academic should be required to undertake research ethics training. It was necessary for research staff but there was some uncertainty around whether academic staff, who were supervising project work of undergraduate students and who did not regard themselves as researchers, should also take the course. At the same time, RETI would be asked whether there was any scope to make access to the Epigeum training easier although it was recognised that this could be a licensing issue.

EXTERNAL REC APPROVAL

ANY OTHER BUSINESS

42.1 Issues Raised During Consideration of Research Applications

42.1.1 New Online System for Approvals

While considering the research applications, the Committee identified several issues relevant to the development of the new online approval system for research bids and applications which it wished to be fed back to RETI. These included:

- i. Enabling all accompanying documentation to UREC project applications to be reached via links on online equivalent of the UREC form
- ii. The need for the approval process to include confirmation of any contractual arrangements necessary for the project
- iii. The request that UREC Committee Members have the opportunity to pilot test the on-line approval system before going live.

42.1.2 Student Consent to Use Personal Data

The Committee noted that student data collected by the University could potentially be available for use as secondary data, in anonymized form, for other research projects. It was desirable that students' permission to use this data for future internal research purposes should be obtained at the outset rather than retrospectively. The University Secretary would ask the Information Compliance Manager to review the relevant student privacy notices.

42.1.3 Contractual Arrangements for Research Projects

Arising out of consideration of an application, the Committee agreed that the UREC Application Form should be amended for 2021/22 to include a section requiring the applicant to describe any contractual arrangements with third parties (other than research funders) that were associated with research projects. E.g. where a third party would be contracted to carry out aspects of the project such as data gathering or where a data sharing agreement with a third party would be put in place.

The Committee suggested that RETI should be asked to include guidance for research staff on the consideration of contractual arrangements for research projects on their webpages.

42.3 Ethical Approval of Research Projects Undertaken as Part of a Programme

The FEHHS FREC representative noted that the University Research Ethics Policy stated that all research involving vulnerable people required ethical approval from UREC, including UG and PGT projects. In the School of Education, all teacher training courses required students to complete an assessment involving children, and if this policy was followed to the letter, UREC would be over-whelmed with applications. The Committee acknowledged that it was likely that there were other areas across the Faculties where these types of assessments were standard practice. It was agreed that a standing delegation to the Faculty/School research ethics committee to manage

these assessments would be the most appropriate way forward. A proposed form of wording for the standing delegation would be brought back to the Committee for future consideration.
